On April 16th, the Department of State and the Department of Commerce published regulations implementing the first round of changes resulting from the Export Control Reform Initiative. Companies have until October 15, 2013, the effective date of the regulations, to adapt to these significant changes in the area of export control compliance. This program will summarize these changes and provide a discussion of the steps companies should be taking now to ensure compliance.
