Stephen Joske is the Director of the Economist Intelligence Unit's China Forecasting Service in Beijing. He speaks Chinese and has been visiting China since 1978. From 2004 to 2007 he worked at the Australian Embassy in Beijing as the Senior Australian Treasury Representative to China. Before working starting work at the EIU he was the senior analyst on the Chinese economy for the Australian Office of National Assessments, providing advice directly to the Australian prime minister. He also worked for a number of years as Senior Adviser on macroeconomic policy on the personal staff of the former Australian Treasurer Peter Costello.



Bill Liu is a Vice President at NaviAsia Consulting Group. He helps US companies with their strategy, marketing, and operations management- with a focus on China. Prior to joining NaviAsia, Bill worked for Lucent Technologies, PriceWaterhouseCoopers, and Waste Management, Inc.
